2020 Annual Minutes

2019 - 21 Treasurers' Report

2021 Vice-Chairman's Report

- Francisco congratulated Phil Pruett (Pommel Horse), Luis Martinez-Lopez (Floor) and Will Fontanez (Parallel Bars) on their nomination as Region 8 Regional Apparatus Leaders. He acknowledged the last year's difficulties and thanked everyone for their hard work.

2021 Chairman's Report

- Last year only one exchange. That was with Ozone in Tennessee. Shane and Francisco went to that competition. Last year's season was limited due to COVID and SGJA was still able to send Officials to Regionals and Nationals.
- Florida events still ran. However, the number of entries and officials needed were both lower.
- Bid Forms should be completed and emailed to Shane.

Old Business

- Congratulations to the 2020 Judge of the Year, Phil Pruett.
- Francisco thanked the SGJA for its support of his assignment to the African Championships.

New Business

- The JO and National Exams are available at www.ngja.org. A candidate must complete both exams prior to receiving an assignment to a competition. Candidates must also have current USAG Pro Membership, Safe Sport, U113 and Background Check.
 - Dean spoke about the importance of taking the exams in one sitting. The exam will time out if you take too long or walk away and come back later. If this happens, contact Mark Sherman. His email address is available at www.ngja.org.
 - Shane commented that the written exam is more difficult this year with a focus on the changes from the previous Code.
- 2022 Judge of the Year
 - Nominations due by early February, voted by late February and awarded at State Meet. Nominations will come from SGJA Members and voted upon by SGJA members and additional votes – one per club.
- State Apparatus Leaders will change this year. If anyone is interested, contact Shane by October 22nd with your top three event choices.
- Judges must complete the SGJA Bid Form and return to Shane. Antonio suggested that Judges provide information on whether, or not, they are willing to share a room and with whom.
- With the increased membership and fewer, and smaller, competitions this year, there will be fewer possible assignments. Judges are encouraged to attend the Judges Cup if they are interested in being assigned to competitions this year.
- Assignments will be based more on using Judges from the local area around the competition.
- There is no current Association rule about judges driving solo, or rooming solo. Judges will be surveyed regarding with whom they would room, if anyone, and if there is another judge with whom they would be willing to carpool.
- The 40 athlete minimum per session will be kept for the upcoming season. Motion to keep the 40 minimum Dryer, 2nd Bittner.
- Election of Officers
- Next year is the election of new Officers. Anyone interested should reach out and start learning the position they are interested in.
- Dean suggested a live course for 2022, barring the unforeseen. Discussion ensued including the difficulty of travel, a hybrid format where the course would be a Zoom course and the practical test would be administered at the Judges' Cup.
- Josh Bittner suggested establishing an SGJA Service Award. He will spearhead that idea.
